ADOPTED ON MAY 14 1985

WHEREAS, BOOTSTRAP II LTD. applied for a waiver of Emergency Ordinance No. O-16332 (New Series) to permit development of a 16-unit apartment complex on the north side of National Avenue, between 37th and 38th Streets, described as Lots 41 through 44, Block 407, Helpingstine's Addition, Map No. 450, in the R-1000 Zone of the Southeast San Diego Community Plan area, without requiring a discretionary permit incorporating design review; and


WHEREAS, the Planning Department of The City of San Diego, in its Report No. 85-215, filed in the office of the City Clerk on April 11, 1985, recommended denial of the project; and

WHEREAS, the matter was set for public hearing on May 14, 1985 before the Council of The City of San Diego, testimony having been heard, evidence having been submitted and the City Council having fully considered the matter and being fully advised concerning the same; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the proposed project is consistent with the objectives of Project First Class, which necessitated implementation of Emergency Ordinance No. O-16332 (New Series).

BE IT FURTHER RESOLVED, that the application of BOOTSTRAP II LTD. for a waiver of Emergency Ordinance No. O-16332 (New Series) be, and the same is hereby approved.
