Donna J. Baker	Police	\$580.00	Ms. Baker was a Senior Typist with the Police Department at the time of her suggestion. She suggested the revision of the system for processing paperwork on juvenile contacts. This has resulted in a time savings of \$7,426. This is the remainder of her award.
Jan E. Johnson	Clerk	\$425.00	Ms. Johnson was a Intermediate Typist with the Clerk's office at the time of her suggestion. She suggested obtaining a labeling machine for use in the Clerk's office. This has resulted in a time savings of \$2,199. This is the remainder of her award.
Mary E. Worthington	Personnel	\$230.00	Ms. Worthington is a Senior Typist. She suggested the discontinuance of checking payroll notices against time sheets. This is expected to save \$764.66 in time. This is the full award.
David L. Gerber	Buildings	\$160.00	Mr. Gerber is a Refrigeration Mechanic with the General Services/Buildings Division. He suggested the installation of a demand limiter on the centravac water chiller at the Library. This is expected to save \$1,290.10 in energy costs. This is a partial award pending a 12-month review.
