
RESOLUTION NUMBER R- 263201

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of those easement deeds of CALPAR BUILDING COMPANY, a partnership, dated March 25, 1985, and of BALDWIN BUILDING COMPANY, a California general partnership, dated April 11, 1985, both executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 263201-1 and RR- 263201-2, granting to said City easements for pedestrian and non-motor vehicular right-of-way purposes in a portion of Lot 2, Section 19, Township 14 South, Range 3 West, S.B.M. and in a portion of Parcel 7 of Parcel Map No. 12871, as more particularly described in the deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for pedestrian and non-motor vehicular right-of-way.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
