BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Charles W. Christensen, a registered civil engineer, entitled "GENESEE GARDEN VILLAS RESUBDIVISION, being a subdivision of Lot 1 Genesee Garden Villas, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 9648, filed in the office of the County Recorder of San Diego County May 9, 1980, together with Nightingale Way, Hummingbird Lane and portions of Meadow Lark Drive and Canary Way as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.



act of the Council, that said Council has approved said subdivision map and that the easements with the right of ingress and egress for the construction and maintenance of sewer facilities, as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
