
ADOPTED ON MAY 20 1985

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to the authority delegated to the City under California Vehicle Code Section 35700 et seq., commercial vehicles with a gross vehicle weight of over 10,000 pounds, be and the same are hereby prohibited from operating on Calle de las Rosas between Rancho Penasquitos Boulevard and Orangeburg Avenue.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same are hereby authorized to be made on said streets, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
