
RESOLUTION NUMBER R- 263224

BE IT RESOLVED, by the Council of The City of San Diego, that this Council concurs with the City Manager's recommendation to establish a commercial loading zone on the northerly side of Prospect Street, between Cave Street and Fay Avenue, effective during the hours of 3:00 a.m. to 9:30 a.m., Monday through Friday, during those hours, commercial vehicles actively engaged in the process of loading or unloading may park parallel to the curb, excluding that portion of Prospect Street extending east of Jenner Street for 150 feet.
