WHEREAS, on May 22, 1985 the San Diego Transit Board is scheduled to consider the purchase of three trolley-type speciality vehicles, and

WHEREAS, these vehicles would be used in part for the "Sunrunner" beach area shuttle system scheduled to begin summer service on June 16, 1985, and

WHEREAS, said vehicles would provide an attractive, enjoyable and distinctive means of public transportation for visitors and residents to our City's beach areas, and

WHEREAS, the beach area shuttle system represents an important means to increase public access to our City's beaches, while reducing traffic and parking congestion, and

WHEREAS, the City Council has recognized the importance of the beach shuttle by providing operational costs for the last two years, and

WHEREAS, the above transaction represents an opportunity purchase as the three vehicles are available for immediate possession and use, NOW, THEREFORE,

BE IT RESOLVED, that the City Council of the City of San Diego supports the San Diego Transit Board's purchase of three trolley-type speciality vehicles for use in part for the beach area shuttle system.
