BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the bids of 1. WESTERN WATER METER CO., INC., 2. NEPTUNE WATER METER COMPANY, 3. KENT METERS, INC., 4. BADGER METER, INC., 5. HERSEY PRODUCTS INC., 6. CARLON METER COMPANY, and 7. ROCKWELL INTERNATIONAL are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of WATER METERS AND PARTS as may be required for the period of one (1) year beginning June 1, 1985 through May 31, 1986 per prices on file in the Purchasing Department as follows:

1. WESTERN WATER METER CO., INC. for Schedule I, Items 1 through 4, Item 6 and Schedule II, Items 3 and 4, and parts for ARAD Meters: terms 2% 20 days, with an option to renew contract for an additional one (1) year period subject to a price escalation not to exceed 10% of initial year contract prices.
2. NEPTUNE WATER METER COMPANY for Schedule I, Item 5, Schedule II, Items 1, 2, 7 and parts for Neptune Meters; terms net 30 days, with an option to renew contract for an additional one (1) year period subject to a price escalation not to exceed 4% of initial year contract prices.
3. KENT METERS, INC. for Schedule II, Item 5 and parts for Kent Meters; terms net 30 days, with an option to renew contract for an additional one (1) year period with no price escalation of the initial year contract prices.
4. BADGER METER, INC. for Schedule I, parts for Badger Meters only, Schedule II, Item 6 and parts for Badger Meters; terms net 30 days with an option to renew contract for an additional one (1) year period subject to a price escalation not to exceed 5% of the initial year contract prices.
5. HERSEY PRODUCTS INC. for Schedule I and Schedule II, parts for Hersey Meters only, Schedule III, Items 1 and 2 and parts for Hersey Meters; terms net 30 days, with an option to renew contract for an additional one (1) year period subject to a price escalation not to exceed 9% of the initial year contract prices.
6. CARLON METER COMPANY for Schedule I, parts for Carlon Meters only; terms net 30 days, with an option to renew contract for an additional one (1) year period subject to a price escalation not to exceed 9.5% of the initial year contract prices.

7. ROCKWELL INTERNATIONAL for Schedule I and Schedule II, parts for Rockwell Meters only, terms net 30 days, with an option to renew contract for an additional one (1) year period subject to a price escalation not to exceed 5% of the initial year contract prices.
