


RESOLUTION No. R-263250 (R-85-2066)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of KINNETIC LABORATORIES, INC is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing SORTING OF OCEAN BENTHIC SAMPLES as may be required for a period of one (1) year beginning June 1, 1985 through May 31, 1986 at a cost of \$82.00 per sample for a total estimated cost of \$29,520.00; terms 2% 30 days, with an option to renew contract for two (2) additional one (1) year periods with an escalation not to exceed 10% of prices in effect at the end of each year.
