RESOLUTION NUMBER R- 283263

ADOPTED ON MAY 28 1985

WHEREAS, in August 1983, Presidents Reagan and de la Madrid formally designated the United States Environmental Protection Agency (EPA) as the national coordinator to protect and improve the environment in the border area; and

WHEREAS, EPA recognized this responsibility by designating a full-time border coordinator in San Diego; and

WHEREAS, the border coordinator has provided invaluable service and support to local and state agencies impacted by the problems related to raw sewage and/or toxic flows from Mexico into the United States; and

WHEREAS, the EPA recently announced that the border coordinator position would be relocated to the Region 9 headquarters in San Francisco even though the problems associated with these flows have not been solved; and


WHEREAS, the Rules Committee, at its regularly scheduled meeting of May 13, 1985, considered the information and recommendation presented in IRD Report No. 85-50 and approved it by a 4-0 vote; and

WHEREAS, the Rules Committee now forwards the matter to the full Council for appropriate action; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the United States Environmental Protection Agency is requested to retain the position of border coordinator in San Diego unless and

until the problems associated with raw sewage and toxic flows are permanently solved.
