BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a one-year Use and Occupancy Permit with SAN DIEGO UNIFIED PORT DISTRICT, for the use by the Police Department of 60,000 square feet of Port District Tidelands for parking purposes, at a rent of \$2,000 per month, under the terms and conditions set forth in that Use and Occupancy Permit on file in the office of the City Clerk as Document No. RR- 263272 - 2

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$10,560 from the Police Department Budget for Fiscal Year 1985-86, to cover the difference in the two rental amounts, is hereby authorized and approved.
