BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

ADAMS FIELD HOUSE REPLACEMENT.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$287,000: including \$272,000 from Community Development Block Grant Funds 185191, CIP No. 29-462.0 ADAMS FIELD HOUSE REPLACEMENT (PSD 600), Dept. 5731, Org. 3115 (\$172,000) and Fund 18520, Dept. 5813, Org. 1301 (\$80,000); and \$15,000 from Revenue Sharing Fund 18013, CIP No. 58-007 ANNUAL ALLOCATION - OVERHEAD & OTHER CITY COSTS FOR FEDERAL GRANTS is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
