BE IT RESOLVED, by the Council of The City of San Diego as follows:


That the specifications for the furnishing of RENTAL OF TEMPORARY DOWNTOWN RESTROOM FACILITIES - PORTABLE TOILETS filed in the office of the City Clerk of the City of San Diego, California, on MAY 28 1985, and bearing official Document No. RR- 263277, be, and the same are hereby approved.

That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for RENTAL OF TEMPORARY DOWNTOWN RESTROOM FACILITIES - PORTABLE TOILETS.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsive and reliable bidder or bidders for this service.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$50,000 from Transient Occupancy Tax Fund (10223) is hereby authorized solely and exclusively for said contract and related costs and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
