


RESOLUTION No. R-263286 (R-85-2065)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bid of PEDUS BUILDING SERVICES, INC. is hereby accepted and the City Manager is hereby authorized to execute an agreement with PEDUS BUILDING SERVICES, INC. for furnishing CUSTODIAL AND MAINTENANCE SERVICE OF SAN DIEGO JACK MURPHY STADIUM as may be required for a period of three (3) years and nine (9) months beginning June 1, 1985 through February 28, 1989, at wage rates on file in the Purchasing Department, plus a total surcharge of 26.35%, with an option for either party to cancel the agreement upon ninety (90) days written notice.
