BE IT RESOLVED, by the Council of The City of San Diego as follows:



That the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for services of a vendor or vendors to furnish RISERS AND CONES TO REBUILD MANHOLES throughout the City of San Diego.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsive and responsible bidder or bidders for this service.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$16,000, from Dept. 700, Org. 653, Obj. Acct. 3316, J.O. 4445 is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
