

BE IT RESOLVED, by the Council of The City of San Diego as follows:

- 1. That the bid of \$531,000 by FRITZ A. NACHANT, INC., a corporation, for CONSTRUCTION OF COLINA DEL SOL COMMUNITY IMPROVEMENTS in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 118226.
- 2. That the City Auditor and Comptroller is hereby authorized to transfer \$105,000 (\$54,671 from Park Service District Fund 15590; \$7,137 from Park Service District Fund 15592; and \$43,192 from Park Service District Fund 15601) to CIP No. 29-441 COLINA DEL SOL COMMUNITY PARK IMPROVEMENTS.
- 3. That the expenditure of \$105,000 from CIP No. 29-441 COLINA DEL SOL COMMUNITY PARK IMPROVEMENTS to supplement funds for said project and related costs; and authorizing the Auditor and Comproller, upon advice from the administering department to transfer excess budgeted funds, if any, to the appropriate reserves.
