WHEREAS, the City Manager concurs with the recommendation of the agencies that in addition to alternatives 1d and 7c the City Council should endorse alternative 7b contingent upon the availability of sufficient funding from Federal and/or State sources; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that alternative 7b of the Report is endorsed as the preferred interim solution provided sufficient funds can be appropriated through Federal and/or State legislation.

BE IT FURTHER RESOLVED, that the Intergovernmental Relations
Department is hereby directed to seek appropriate Federal and/or
State legislation to obtain appropriate support and action.
