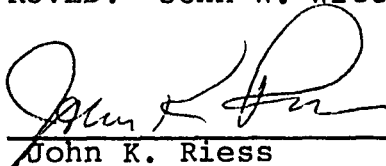
ADOPTED ON JUN 10 1985

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$85,500 from CIP 64-004, "Railroad Warning Devices," Capital Outlay 30245, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
