APPROVING MAP OF CARMEL VALLEY NEIGHBORHOOD 5 UNIT NO. 8

BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by Tom R. McGannon, a registered civil engineer, entitled "CARMEL VALLEY NEIGHBORHOOD 5 UNIT NO. 8, being a subdivision of a portion of Parcels 15, 26, 27 and 28 of Parcel Map No. 12871, filed in the office of the County Recorder of San Diego County, August 26, 1983 and Lots 103 through 110, inclusive, of Carmel Valley Neighborhood 5 Unit No. 5, per Map No. 11079, filed in the office of the County Recorder of San Diego County, November 9, 1984, in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: Portada Place, Maestro Court, Manifesto Place, Mancilla Court and Del Mar Trails Road, and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements listed in paragraphs 1, 2, 3 and 4 of the Owner's

Certificate, as shown on this map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said streets are accepted on behalf of the public as heretofore stated; and that those easements listed in paragraphs 1, 2, 3 and 4 of the Owner's Certificate, as granted and shown on this map, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
