
RESOLUTION NUMBER R- 263406

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of Section 85.02 of the San Diego Municipal Code, a TRUCK PARKING PROHIBITED ZONE, be and the same is hereby established on the east side of Morena Boulevard from Asher Street to a point 500 feet south of Asher Street.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
