BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized, for and on behalf of said City, to execute the 1985 Group Medical and Hospital Service Agreement with KAISER FOUNDATION HEALTH PLAN to: (a) extend contract for the one-year period August 1, 1985 through July 31, 1986, (b) add Kaiser's Residential Treatment Program for alcohol and drug rehabilitation, and (c) authorize a premium rate increase, as follows:
