RESOLUTION NUMBER R- 263409

ADOPTED ON JUN 17 1985

WHEREAS, the San Diego Regional Ridesharing Project (Commuter Computer) was initiated in 1975 with a cooperative agreement among The City of San Diego, CALTRANS, the County of San Diego and SANDAG; and

WHEREAS, this project was subsequently extended, with Council approval, through several supplemental agreements and CALTRANS has requested that the project now be extended for an additional period; and

WHEREAS, the overall purpose of the Regional Ridesharing Project is to reduce air pollution, fuel consumption, traffic congestion and parking requirements by encouraging and assisting ridesharing and although a wide range of services are provided to encourage all ridesharing activities, the project's major emphasis is on establishing and maintaining ridesharing programs at major employment sites; and

WHEREAS, the Regional Ridesharing Project is funded through Federal Aid Urban Funds for the San Diego region and Federal Aid Primary Funds by CALTRANS; and

WHEREAS, it is now necessary to execute the necessary Ridesharing Program agreement with the various agencies involved;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and

empowered to execute, for and on behalf of said City, a Ridesharing Program agreement between The City of San Diego, the State of California, the County of San Diego, and the San Diego Association of Governments, for the purpose of continuing the San Diego Regional Ridesharing Project, for the period October 1, 1985 through September 30, 1986, pursuant to the terms and conditions of the Ridesharing Program agreement on file in the office of the City Clerk as Document No. RR- 263409.
