WHEREAS, Section 22.0101 of the San Diego Municipal Code establishes Permanent Rules of the Council; and

WHEREAS, Rule 1 thereof governs the hours of meetings and establishes the times and procedures to be followed when scheduling meetings of the City Council; and

WHEREAS, Rule 1 subsection (d) was amended by Ordinance O-16064 (New Series), effective October 24, 1983, to provide for night council meetings on a quarterly basis, the date, time and location thereof to be established by resolution of the Council; and

WHEREAS, it is now necessary to resolve, pursuant to the provision of Rule 1(d) the date, time and location of the above cited evening council meeting; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that pursuant to the authority and provisions of Rule 1(d) of the Permanent Rules of the Council, set forth in Section 22.0101 of the San Diego Municipal Code, it is hereby declared that the quarterly night City Council meeting scheduled for June 25, 1985 shall be conducted at the Town and Country Hotel, San Diego, California (in the Mission Valley area), said meeting scheduled to commence at 7:00 p.m.

BE IT FURTHER RESOLVED, that the City Clerk is directed to make such arrangements as may be required and be authorized to

expend the necessary funds for such facilities from the General Fund 100, Department 035.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to post and publish, as necessary, the notice of such meeting with the date, time, and location thereof.
