RESOLUTION NUMBER R- 263422

ADOPTED ON JUN 17 1985

WHEREAS, 7th District Councilmember Dick Murphy has been appointed a Municipal Court Judge of the San Diego Judicial District and is expected to resign as a Councilmember on July 1; and

WHEREAS, Section 12 of the Charter of The City of San Diego provides that any vacancy occurring in the Council shall be filled from the District in which the vacancy occurs by appointment by the remaining Council members; and

WHEREAS, the San Diego Municipal Code establishes a procedure for filling vacancies in elective offices in Sections 27.3101 through 27.3108; and

WHEREAS, pursuant to Section 27.3102 the Mayor called a special meeting of the Council to be consolidated with the regular meeting of June 17, 1985; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the schedule enumerated in Exhibit A attached hereto and made a part of this resolution is hereby adopted as the schedule to follow in order to comply with the procedures provided by Sections 27.3101 through 27.3108 of the San Diego Municipal Code.

SUBJECT: Appointment Calendar for District 7 Council Vacancy

Pursuant to the provisions of Division 31 of the Municipal Code, the following calendar of events is recommended for the appointment process for the vacancy currently scheduled to occur in Council District 7 on July 1, 1985:

June 17, 1985	Council Docket item announcing vacancy and set applicant hearing dates.
June 19, 1985	Clerk publishes notices of vacancy pursuant to Municipal Code.
June 19, 1985	First day for filing applications
July 1, 1985	District 7 Council office vacated
July 3, 1985	Applicant filing deadline, 5:00 p.m. (14th day after date of publication of notice of vacancy)
July 8, 1985	First public hearing
July 15, 1985	Second public hearing
July 31, 1985	Appointment process must be completed

It is presumed that the public hearings for applicants could be part of the Monday afternoon Council meetings on July 8 and July 15, respectively. The nomination period for Council candidates closes on Friday, July 19, 1985.


Some flexibility exists for the scheduling of the first and second hearings; however the last date that a second hearing could be held is July 31, 1985.



