RESOLUTION NUMBER R- 263425

ADOPTED ON JUN 17 1985

BE IT RESOLVED, by the Council of The City of San Diego, that there is hereby created, pursuant to Section 43(b) of the City Charter, an advisory committee to be known as the "Mission Gorge Road Improvement Committee," which Committee shall advise the City Council on the following projects:

1. Design and maintenance of the landscaping of the center median on Mission Gorge Road between Zion Avenue and Allied Road, paid for by Kaiser.

2. Design and maintenance of the landscaping on the north side of Mission Gorge Road between Princess View Drive and Margerum Avenue, a condition of the V.R. Dennis C.U.P.

3. Design and construction of colored, stamped, concrete center medians on Mission Gorge Road.

4. Undergrounding of utilities along Mission Gorge Road.

5. The Grantville Precise Plan.

6. Such other activities as would enhance the aesthetics of Mission Gorge Road.

BE IT FURTHER RESOLVED, that the Committee shall be temporary in nature and shall advise the City Council with regard to the above matters during the period July 1, 1985 through June 30, 1987.

BE IT FURTHER RESOLVED, that the Committee shall be made up of the following persons and representatives:

1. A representative of the people living east of Margerum Avenue in the vicinity of Mission Gorge Road, which representative shall initially be Dick Murphy.

2. A representative of the people living west of Margerum Avenue in the vicinity of Mission Gorge Road, which representative shall initially be Joe Miller.

3. A representative of businesses doing business in the vicinity of Mission Gorge Road, which representative shall initially be Gary Dennis.

4. A representative of the Navajo Community Planners.

5. A representative of the San Carlos Area Council.


BE IT FURTHER RESOLVED, that the Committee shall meet at least quarterly and at such other times as deemed necessary by the Committee for the conduct of its business.

BE IT FURTHER RESOLVED, that Dick Murphy is hereby appointed chairman of the Committee.

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to assign an appropriate City employee to act as a liaison to the Committee.
