

RESOLUTION NUMBER R- 263426

ADOPTED ON JUN 17 1985

WHEREAS, the following three park sites presently have no identification signs:

1. Princess Del Cerro Neighborhood Park,
2. Grantville Neighborhood Park,
3. Navajo Canyon Open Space; and


WHEREAS, it is desirable and appropriate that small simulated wood fiberglass signs identifying the names of said park sites be constructed at the following locations:

1. Princess Del Cerro -- in the middle of the park adjacent to Weinrich Drive,
2. Grantville -- at the corner of Vandever and Crawford,
3. Navajo Canyon -- in the middle of the entrance to the canyon at the end of Navajo Road; NOW, THEREFORE,

BE IT RESOLVED, that the City Manager is hereby directed to prepare proposed specifications for said signs together with Auditor's Certificates and to bring them back to the City Council so that the projects can be put out to public bid.

BE IT FURTHER RESOLVED, that monies for the construction of said signs shall come from the appropriate park service district funds.
