Jim A. Toci	Engineering & Development	\$5,000.00	Mr. Toci was an Assistant Electrical Engineer at the time of this suggestion. He suggested the installation of City-owned phone lines between the yard at 20th and B and the City Operations Building. This is expected to save \$22,628 in leasing costs during the first year. This is the full award.
Dennis L. Marnell	General Services	\$ 500.00	Mr. Marnell is a Mechanic in the Equipment Division. He suggested the use of pictorial schematics to repair the master truck wiring. Although savings were difficult to identify, this was considered to be a significant operational improvement.
