WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Jack A. Swerlein	Utilities	\$280.00	Mr. Swerlein is a Waste Water Plant Operator at Aqua I. He suggested the use of a float controlled gate valve to regulate the water level in the sewage feed tanks. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Jim A. Toci	Engineering & Development	\$220.00	Mr. Toci was an Assistant Electrical Engineer at the time of this suggestion. One year ago he earned a partial award of \$190.00 for his suggestion to eliminate unnecessary lighting along Quivera Road and Quivera Way. One years experience has shown \$1,368.00 in energy savings. This is the remainder of his award.
David B. Baldwin	General Services	\$160.00	Mr. Baldwin was a Mechanic in the Equipment Division at the time of his suggestion. He suggested the use of the neutral switch to eliminate mechanically activated micro switches. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Charles T. Crouch, Frank C. Welsch	Utilities	\$ 90.00	Mr. Crouch was a Plant Maintenance Supervisor and Mr. Welsch a Plant Maintenance Mechanic at the time of this suggestion. They suggested the use of an existing effluent line for a sump pump. This resulted in a \$300.00 savings for the cost of a new line.
