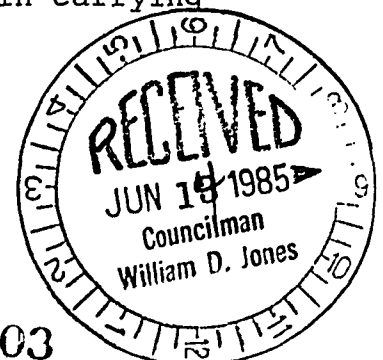
WHEREAS, under this leadership, United Way last year raised over \$20 million for 100 San Diego area health and human care agencies; and
