BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$165,800 from Revenue Sharing Fund 18013, CIP No. 29-571 OCEAN BEACH ATHLETIC AREA TENNIS COURT RECONSTRUCTION is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
