BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized and empowered to transfer \$15,000

from Capital Outlay Unallocated Reserve Fund 30245, CIP 90-245 to CIP 29-583 Collier Park - Development, hereby created, for the purpose of engineering design of the project.
