WHEREAS, the American Red Cross is under contract to The City of San Diego to provide lift-equipped transportation to eligible Dial-a-Ride passengers in the central area of the City; and

WHEREAS, the original agreement has been amended on four occasions to extend the term of service and change the method of compensation; and

WHEREAS, the fifth amendment continues the existing contract for service through June 30, 1986 and increases the per hour compensation rate by approximately 10% and decreases the total vehicle hours purchased annually by 17.9%; and

WHEREAS, the 10% hourly compensation rate increase is a result of fixed operating costs remaining constant against the decrease in total vehicle hours required; NOW, THEREFORE

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, a FIFTH AMENDMENT TO PURCHASE OF SERVICE AGREEMENT FOR PROVISION OF SPECIAL TRANSPORTATION (Agreement No. RR-255869-3), with the San Diego/Imperial Counties Chapter of the American Red Cross, for the purpose of providing wheelchair lift-equipped transportation for the City's Dial-a-Ride program, pursuant to the terms and

conditions of the Fifth Amendment to Agreement on file in the office of the City Clerk as Document No. RR- 263491.
