BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the SAN DIEGO LOCAL DEVELOPMENT CORPORATION (LDC), for Fiscal Year 1986 funding amounting to \$407,370, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 263524 .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$4,500 for annual auditing by Gunnarson and Bates and an amount not to exceed \$11,130 for annual program monitoring by George A. Peterson & Co., multi-year contracts which have been previously approved subject to availability of funding, is hereby authorized.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$423,000, eleventh year, from Fund 18521, Department 5835, Organization 3507, is hereby authorized, solely and exclusively for the purpose of providing funds for the above purposes.
