RESOLUTION NUMBER R- 263561

ADOPTED ON JUL 01 1985

WHEREAS, RecyCal is a coalition of local bottling, distributing and manufacturing industries, grocers and retailers, members of refuse removing and recycling industries as well as a nonprofit organization concerned with a clean environment; and

WHEREAS, RecyCal of Southern California is offering The City of San Diego a \$40,000 donation for the specific purpose of hiring forty youths to work five hours a day, four days a week, Friday through Monday, for twelve weeks; and

WHEREAS, youth hired with these funds will work on a summer beach cleanup project; and

WHEREAS, approximately seventeen miles of beaches from La Jolla to Ocean Beach and eight shoreline parks will be designated to receive the benefit of this added attention this summer; and

WHEREAS, as a condition of receiving this donation, the City will be required to have each youth wear a T-shirt and a sun visor with RecyCal logo and RecyCal will provide the T-shirts and sun visors along with a supply of trash bags necessary for the entire program; and

WHEREAS, the Park and Recreation Department will provide supervision of the youths working on the beach cleanup project, however, the Regional Youth Employment program will hire the youths, provide administration, coordinate with RecyCal as well as provide logistical and other supportive services; and

WHEREAS, it is recommended that the generous offer by RecyCal be accepted pursuant to the terms and agreement of the Letter of Understanding which the City Manager will administer; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute that certain Letter of Understanding between said City and RecyCal ~~of~~ Southern California, a copy of which is on file in the office of the City Clerk as Document No. RR- 263561, for the purpose of providing funds for the Summer Litter Control Program on City beaches.


BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to accept, on behalf of The City of San Diego, a donation of \$40,000 from RecyCal of Southern California and deposit that money in a special fund to be established by the Auditor and Comptroller, for the purpose of defraying the cost of hiring forth youths to provide litter control on City beaches during the summer months of 1985, pursuant to the terms and conditions of the Letter of Understanding.
