
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with FRIEDSON/ROBBINS AND ASSOCIATES, for professional services for design of Coastal Division Headquarters-Building Addition and Mission Bay Harbor Patrol Docks, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 263568 .

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$15,500 from CIP No. 22-039 Annual Allocation-Mission Bay General Improvements and Landscaping to CIP No. 22-060 (\$11,700) and CIP No. 22-061 (\$3,800) .

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$44,700 from CIP No. 22-060, Coastal Division Headquarters-Building Addition and \$13,800 from CIP No. 22-061, Mission Bay Harbor Patrol Docks, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
