WHEREAS, the City Council has authorized execution of an Agreement with the San Diego Housing Commission for use of 1984 CDBG funds and the City Manager has executed said Agreement as Document No. RR-262082; and

WHEREAS, a portion of the funds authorized by that Agreement are unexpended; and

WHEREAS, a need exists to provide temporary shelter for homeless women in the downtown area; and

WHEREAS, the Secretary of the Department of Housing and Urban Development has determined that CDBG funds may be used to operate shelters for the homeless; and

WHEREAS, the YWCA of San Diego, downtown branch, can provide space but not operating funds for such a shelter; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to amend, for and on behalf of said City, the "Scope of Services," "Budget," and "Work Program" of 1984 CDBG Agreement with the Housing Commission to include operating funds for temporary shelter as a program activity.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$7,875 of CDBG funds, is hereby authorized, solely and exclusively for the purpose of providing funds for the above program.
