RESOLUTION NUMBER R- 263584

ADOPTED ON JUL 01 1985

WHEREAS, the Council of The City of San Diego has allocated Community Development Block Grant (CDBG) funds to the San Diego Housing Commission for low-income housing purposes and has executed Agreements for the use of eighth (1982), ninth (1983), and tenth (1984) entitlement year CDBG funds with the Commission; and

WHEREAS, a portion of the funds allocated for housing site improvements and for predevelopment planning in each of those years is currently available; and

WHEREAS, the proposed Redwood Villas project, which will provide 92 housing units for elderly and will rent a portion of those units to low-income seniors, qualifies as a purpose for which the CDBG fund allocation was intended; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Housing Commission is hereby authorized and empowered to expend an amount not to exceed \$60,000 each from the San Diego Housing Commission's 1982, 1983, and 1984 allocations of CDBG funds for Predevelopment Planning and Site Improvements costs in connection with the Redwood Villas housing development project.
