RESOLUTION NUMBER R- 263589

ADOPTED ON JUL 01 1985

WHEREAS, the worst fire in the history of San Diego burned along the south rim of Mission Valley on June 30, 1985 and destroyed approximately seventy homes in the community of Normal Heights; and

WHEREAS, despite the valiant efforts and assistance of the San Diego Fire Department, the San Diego Police Department and the residents of Normal Heights, at least the same number of families are without shelter and will require assistance from The City of San Diego in a number of areas; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager be and he is hereby directed, by and through the Building Inspection Department and any other appropriate City agencies and departments, to survey the area affected by the disastrous fire of June 30, 1985 and determine the address and location of each dwelling or dwellings damaged or destroyed.

2. That the City Manager be further authorized and directed to take necessary action by and through appropriate City agencies and departments, to give priority to those people affected by

this conflagration, to obtain building permits to rebuild their homes in accordance with all applicable laws.
