RESOLUTION CONSIDERING THE PROTESTS, APPROVING MODIFIED MAP, CONFIRMING THE ASSESSMENTS, AND ORDERING THE PROPOSED MAINTENANCE, IN THE MATTER OF THE GASLAMP QUARTER LANDSCAPE AND LIGHTING MAINTENANCE DISTRICT.


WHEREAS, the notice of the time and place fixed for the hearing of protests in the matter of the Gaslamp Quarter Landscape and Lighting Maintenance District, under Resolution of Intention No. R-263349, adopted on June 10, 1985, having been duly given in the manner required by law and the legal time for filing such protests and the time fixed for hearing thereon having passed; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The protests, if any, are overruled.
2. The assessments described in Document No. RR-263350, as amended by the Amendment to the City Engineer's Report, as described in Document No. RR-263592, both Documents on file in the office of the City Clerk and on file in the office of the Street Superintendent, are hereby confirmed and approved.
3. the modified assessment district map for the Gaslamp Quarter Landscape and Lighting Maintenance District, described in Document No. 769180 is hereby approved.

4. The maintenance described in said Resolution of Intention is hereby ordered performed, except that Optional Items Nos. 3, 4, and 5 are hereby deleted.
