

RESOLUTION NUMBER R- 263593

ADOPTED ON JUL 2 1985

A RESOLUTION AMENDING THE PROGRESS GUIDE AND GENERAL PLAN TO REFLECT THEREIN THE NORTHSIDE SPECIFIC PLAN, SAN DIEGUITO RIVER REGIONAL PLAN, MID-CITY COMMUNITY PLAN, CARMEL VALLEY NEIGHBORHOOD 4, 5 & 6 PRECISE PLAN, BLACKHORSE FARMS AND CENTER SPECIFIC PLAN, UNIVERSITY COMMUNITY PLAN, THE OTAY MESA REORGANIZATION, M. V. ASSOCIATES REORGANIZATION, DALEY ISLAND REORGANIZATION AND THE PHASED DEVELOPMENT AREAS MAP.

WHEREAS, California Government Code Sections 65350 to 65361, inclusive, require that amendments to the City's PROGRESS GUIDE AND GENERAL PLAN shall require successive affirmative votes by both the Planning Commission and Council of The City of San Diego but limits amendments to mandatory elements of the General Plan to four per year; and

WHEREAS, City Council Policy 600-7 establishes procedures for amending the General Plan, including the stipulation that possible amendments resulting from prior Planning Commission and Council actions on specific plans, programs, policies and major zoning issues, together with requests for General Plan revisions initiated by private parties, City departments or other public agencies shall be accumulated and periodically scheduled for combined public hearings and Council action, so as not to exceed the limits imposed by Section 65361; and

WHEREAS, within the period October 1, 1984 to April 1, 1985, the Council of The City of San Diego has approved the following:

1. The Northside Specific Plan (adopted October 30, 1984 by Council Resolution No. 261850) and associated EIR-82-0556 (certified by Council Resolution 261847).

2. The San Dieguito River Regional Plan (adopted October 30, 1984 by Council Resolution 261854) and associated ND-84-0550 (certified by Council Resolution 261852).

3. The Mid-City Community Plan (amended December 4, 1984 by Council Resolution 262091) and associated EIR-84-0242 (certified by Council Resolution 262089).

4. The Carmel Valley Neighborhood 4, 5 & 6 Precise Plan (amended December 18, 1984 by Council Resolution 262228) and associated ND-84-0594 (certified by Council Resolution 262225).

5. The Blackhorse Farms and Center Specific Plan (adopted January 8, 1985 by Council Resolution 262308) and associated EIR-82-0383 (certified by Council Resolution 262307).

6. The University Community Plan (amended January 8, 1985 by Council Resolution 262308 in conjunction with the Blackhorse Farms and Center Specific Plan adoption) and associated EIR-82-0383 (certified by Council Resolution 262307).

7. The Otay Mesa Reorganization (annexation effective March 14, 1985) and EIR-84-0297 (certified by Council Resolution 262621).

8. The M. V. Associates Reorganization (annexation effective March 21, 1985) and associated EIR-82-0556 (certified by Council Resolution 262444).

9. The Daley Island Reorganization (annexation effective March 25, 1985) and exempted from the California Environmental Quality Act, Class 19, Categorical Exemption); and


WHEREAS, the Planning Commission and Council of The City of San Diego conducted public hearings on May 23, 1985 and July 2, 1985, respectively, to consider amending the General Plan and Phased Development Areas Map to reflect those plans and annexations approved by City Council between October 1, 1984 and April 1, 1985; and

WHEREAS, said proposed amendment to the PROGRESS GUIDE AND GENERAL PLAN will not become effective until approved by the Planning Commission and adopted by the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the said amendments to the GENERAL PLAN and the Phased Development Areas Map of the PROGRESS GUIDE AND GENERAL PLAN of The City of San Diego be, and the same are hereby adopted.
