RESOLUTION NUMBER R- 263619

APPROVING MAP OF LINCOLN - LA JOLLA UNIT NO. 1

BE IT RESOLVED, by the Council of The City of San Diego that said Council hereby finds that certain map surveyed by Charles W. Christensen, a registered civil engineer, entitled "LINCOLN - LA JOLLA UNIT NO. 1, being a subdivision of Parcels 1 and 2 of Parcel Map No. 11572, in the City of San Diego, County of San Diego, State of California, according to the Map thereof filed in the office of the County Recorder of San Diego County, together with portions of Regents Road and Nobel Drive as dedicated to public use, except therefrom all minerals, oil, gas and hydrocarbon substances lying below a depth of 500 feet measured vertically from the contour of the surface of said land but excepting any right of entry in, over or upon the surface of said land and any right of entry in, over, through or upon that portion of said land lying within 500 feet of the surface thereof," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public a portion of Nobel Drive, and said portion of street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Regents Road, adjacent and contiguous to Lot 1, as shown on this map within this subdivision.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of water facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the building restricted easement over, upon and across portions of Lot 1, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and that said portion of a public street is accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of water facilities and the building restricted easement, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
