WHEREAS, the City Council has established Residential Permit Parking Area B in the vicinity of San Diego State University; and

WHEREAS, the City Council believes that the addition of a visitor parking provision would improve the operation of Residential Permit Parking Area B; and

WHEREAS, the residents of Residential Permit Parking Area B have overwhelmingly indicated support for the concept of a Visitor Parking Permit program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to San Diego Municipal Code Section 86.2008 this Council hereby authorizes the issuance of Visitor Parking Permits in Residential Permit Parking Area B.

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to place restrictions upon the face of any Visitor Parking Permit restricting its use to the general area of the residence of the applicant.
