ADOPTED ON JUL 8 1985

BE IT RESOLVED, by the Council of The City of San Diego that the City Manager be, and he is hereby authorized and empowered to do by City Forces all the work to install equipment as required in connection with the expansion of the Police and Fire Departments' automatic receiver selection system, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City Forces more economically than if let by contract. The cost of said work shall not exceed \$25,000.

BE IT FURTHER RESOLVED, by the Council of The City of San Diego, that the expenditure of \$25,000 from Revenue Sharing Fund 18013, consisting of \$21,200 from CIP No. 37-308, Police Department Automatic Receiver Selection System Expansion and \$3,800 from CIP No. 37-312, Fire Communications Systems Expansion, is hereby authorized solely and exclusively for the use of City Forces to expand the Police and Fire Department automatic receiver selection system, and authorizing the City Auditor and Comptroller to transfer unexpended funds to the appropriate reserves upon the advice of the administering department.
