RESOLUTION NUMBER R- 263641

ADOPTED ON JUL 8, 1985

WHEREAS, the California Arts Council (CAC) State/Local Partnership Program (S/LPP) has awarded a grant to The City of San Diego for Fiscal Year 1985-86 in the amount of \$23,990; and

WHEREAS, the City has previously agreed to allocate \$2,000 as a match for the CAC grant; and


WHEREAS, on June 24, 1985, the Rules Committee reviewed IRD Report No. 85-69, dated June 17, 1985, and the recommendations contained therein regarding the conditions of the grant, which include hiring a consultant for the period September 1985 through June 1986 to develop the arts plan for the City, to implement the Programs and services of the Public Arts Advisory Board, and assist in coordinating art and cultural activities in conjunction with the "Downtown '85" program; and

WHEREAS, the Rules Committee approved the recommendations contained in IRD Report No. 85-69; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City agrees to accept the State/Local Partnership Program grant and carry out its conditions.

BE IT FURTHER RESOLVED, that the City Manager, with the cooperation of the Intergovernmental Relations Department, be and he is hereby authorized to issue a Request for Proposals for a consultant to serve as arts coordinator.
