RESOLUTION NUMBER R- 263652

ADOPTED ON JUL 8 1985

WHEREAS, the City Council has approved the establishment of a Senior Center in Mira Mesa and has included said project in the Capital Outlay Program as CIP No. 29-556; and

WHEREAS, the City Council has heretofore allocated the sum of \$500,000 of Revenue Sharing Funds [contained in Fund 18013] toward the development of the Mira Mesa Senior Center; and

WHEREAS, a fundraising event was recently conducted and additional funds were raised for the same purpose; and

WHEREAS, it is possible that additional monies will be forthcoming from various sources; and


WHEREAS, it is now necessary and desirable to create a Trust Fund for the purpose of serving as a repository for such funds for the Mira Mesa Senior Center that have been raised from private sources and such further monies from similar sources as may be forthcoming; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby directed to establish a Trust Fund entitled "Mira Mesa Senior Center Trust Fund" for the purpose of acting as an interest earning repository for funds received from private sources, said funds designated

for the purpose of design and construction of a Senior Center in
Mira Mesa.
