- 4. The maintenance described in said Resolution of Intention is hereby ordered performed with the following revisions to Section 3.
  - 1. The Marina cost is reduced from \$12,000 to \$0.00.
  - 2. The Incidentals are reduced from \$55,266 to \$49,966.
  - 3. The Total Expense is reduced from \$329,995 to \$312,695.
  - 4. The Grand Total is reduced from \$395,995 to \$378,965.
- 5. The Amount Assessed to the District is reduced from \$163,423 to \$146,123.
