WHEREAS, the Council of The City of San Diego held a public hearing on July 9, 1985 to consider a Threshold Determination on an amendment to the the Phased Development Areas Map of the PROGRESS GUIDE AND GENERAL PLAN for The City of San Diego for the purpose of shifting those properties known as THE MYERS GROUP from Future Urbanizing to Planned Urbanizing; and



WHEREAS, the proposed amendment does not conform to Council Policy 600-30 (General Plan Amendments to Shift Land from Future Urbanizing to Planned Urbanizing Area) based on the analysis contained within Planning Report No. 85-322; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Threshold request for an amendment to the Phased Development Areas Map of the PROGRESS GUIDE AND GENERAL PLAN for The City of San Diego to shift those properties known as THE MYERS GROUP from Future Urbanizing to Planned Urbanizing Area be, and the same is hereby denied.
