BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for the Construction of Alvarado Pipeline No. 2, Phase II.

BE IT FURTHER RESOLVED, that the transfer of \$219,662 within the Water Revenue Fund (41502) from the Unallocated Reserve to the Water Systems Construction Program (70592), CIP No. 73-166.1 Alvarado Pipeline No. 2, Phase II is hereby authorized.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$241,730 from Water Reserve Fund 41502, CIP No. 73-166.1 to supplement Resolution No. R-263079 is hereby authorized solely

and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
