

RESOLUTION NUMBER R- 263678 ADOPTED ON JUL 15 1985

BE IT RESOLVED, by the Council of The City of San Diego, that Change Order No. 2, dated May 14, 1985, heretofore filed with the City Clerk of said City as Document No. RR-263678, issued in connection with the contract between The City of San Diego and T.B. PENICK & SONS, INC., a corporation, for the improvement of Logan Heights Block Grant Alley, Street, and Sewer Main Replacement Contract No. 2, said contract having been filed in the office of the City Clerk as Document No. RR-262947, be and the same is hereby approved; and the changes therein set forth, amounting to a net increase in the contract price of \$33,664.21, and an extension of time of 18 calendar days, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$28,000 within the Sewer Revenue Fund 41506 from the Unallocated Reserve (70697) to the Sewer Main Replacement Program (70492) Annual Allocation for Main Replacements, C.I.P. 44-001.



BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$33,664.21 from C.I.P. 44-001, Sewer Revenue Fund 41506, is hereby authorized, solely and exclusively for the purpose of providing funds for the above change order and related costs.
