
ADOPTED ON JUL 15 1985

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to submit an application to the Federal Aviation Agency for a grant of funds for improvements to the runways at Brown Field, in accordance with an application form, a copy which is on file in the office of the City Clerk as Document No. RR- 263679.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized to accept for and on behalf of the City of San Diego, such grants as may be awarded by the Federal Aviation Administration, and apply the same to the purposes for which awarded regarding improvement to the runways at Brown Field;

BE IT FURTHER RESOLVED, that the expenditure not to exceed \$54,585, previously authorized by Resolution No. R-259999 for the runway improvements and matching funds, is hereby authorized solely and exclusively for the City's matching contribution to any federal grant awarded for this project, and further authorizing the City Auditor and Comptroller to transfer excess funds previously authorized to the Airport Unallocated Reserve Fund upon advice of the administering department.
